# Minutes of the Meeting of the State Board of Agriculture April 18, 1940

Appointments

The meeting was called to order at 10:10 A.M.

### RESIGNATIONS, LEAVES AND APPOINTMENTS

- 1. Resignation of Miss Lois Bower as Periodical Librarian, effective April 30, 1940. Miss Bower Resignations has been married recently.
- 2. Resignation of Forest A. Smith as Assistant Professor of Agricultural Education, effective April 15, 1940. Mr. Smith has accepted a position in public relations with a group of chain stores.
- 3. Resignation of Grant Nichol, graduate fellow on Farmers and Manufacturers Beet Sugar Association funds, effective April 15, 1940.
- 4. Leave of absence on half pay for one year fro John Wilde, Grounds Botanist in the Grounds and Botanical Departments, effective September 1, 1940. Mr. Wilde plans to study at Cornell. He has been an employee of the College since 1934.
- 5. Leave of absence without pay for Miss Adele Ewell, Order Librarian, for the period from September 1, 1940, to June 30, 1941. Miss Ewell will study for a Master's degree at the University of Michigan.

5. The Administration account under Buildings and Grounds lacks sufficient funds to complete the year. The building Maintenance account is in the red. There are sufficient funds in other buildings and grounds accounts so that the department as a whole can operate within its budget if Mr. Wilkins is authorized to allow certain of these accounts to run in the red provided the total expenditures do not exceed the total amount budgeted.

6. The Retirement Committee recommends to the State Board the retirement of Mr. A. L. Burtraw effective at once at the minimum retirement rate of \$480.00 per year. Mr. Burtraw was born October 10, 1875. He was hired by the College April 1, 1926 and has been earning \$1080.00 per year as a laborer in the Farm Crops Department.
