

MINUTES OF THE MEETING  
OF THE  
STATE BOARD OF AGRICULTURE  
MARCH 19, 1942

Present: Mr. Berkey (Chairman); Messrs. Akers, Brody, Jakway, McPherson; Mrs. Masselink; President Hannah; Treasurer Wilkins; Secretary McDonel; and Superintendent Elliott.

Absent: No one.

The meeting was called to order at 10:10 A.M.

The minutes of the previous meeting were approved.

On motion of Mr. McPherson, seconded by Mr. Jakway, it was voted to approve the appointment of Mr. William Berkey as Chairman of the Board for a period of two years, to succeed himself.

3. Acceptance of \$75 and approval of the following rules and regulations covering a scholarship loan fund donated by the Grand Rapids PanHellenic Society:
  1. It shall be loaned to a Grand Rapids Girl.
  2. She shall be a junior or senior in an undergraduate college.
  3. The fund shall go to four Michigan colleges represented in the Grand Rapids Panhellenic Society namely, U. Of Mich., Michigan State College, Albion and Hillsdale.
  4. The amount sent to each college shall be determined by the scholarship committee of Grand Rapids Panhellenic with the approval of the board.
  5. The scholarship committees of the above mentioned colleges shall administer the loan, preferably to a sorority member.
  6. The college scholarship committees shall be responsible for the loaning and collecting of these funds and make annual reports to the Grand Rapids Panhellenic Society.

## Rules for Michigan State College Loan Fund:

1. It shall be used as a long term loan with the rate of interest 6%.
2. The loan should not run over a period of two years except in extreme cases.
3. At the time of the loan, a plan for monthly re-payment should be discussed. These re-payments should begin at least four months following graduation with the monthly payments on a ten or fifteen dollar basis depending on employment secured.
4. Acceptance of \$400 and continuation of a memorandum of understanding with the Midwest Soil Improvement Committee providing for a study of fertilizer practices which will improve the yield of corn and other crops grown in the rotation.

On motion of Mr. McPherson, seconded by Mr. Berkey, it was voted to authorize the President, Secretary and Treasurer to proceed with the building of the budget for 1942-43 to be presented in detail at the next meeting of the Board.

21. Approval of a change in the 1942 football schedule which was approved at the November 1941 meeting by substituting Oregon State College for Santa Clara, - Oregon to come here next fall and State to go to Corvallis the following fall. The guarantee is to be \$10,000 on a home and home basis. The game this fall is to be played November 28th instead of October 24th (the date scheduled for Santa Clara).
