Report on Student Fees 6. Professor Emmons made a report for the Committee on Student Fees and Costs, as follows:

1. That the publication fee be separated into its component parts and that the State News fee and the Wolverine fee be voted upon annually; also that the fee for the Michigan Agriculturists be voted upon annually.

2. That the State News fee be decreased to one dollar and twenty cents (\$1.20) per year and paid at the rate of forty cents (\$.40) per term. That the future Wolverine fee be based on the present year's experience.

3. That class dues be reduced to thirty-five cents (\$.35) per term, payable at the beginning of each term.

4. That as soon as the College finances will warrant such a stop, the course fee of thirty-five dollars per term be reduced to thirty dollars per term.

5. That there be printed upon the registration card a statement that the publication fee will be charged to only one member of an immediate family, and that the athletic fee may be remitted to students who find it impossible to attend athletic contents.

6. It is further recommended that publicity be given to the fact and students may petition for a refund of fees other than the Union Fee. The exact wording of this information and the nature of its publicity shall be left to the finance committee.

On motion of Mr. Gowdy, it was voted to adopt Professor Emmons' report.

7. Dean Kedzie brought up the matter of service of Mr. Kelty for the summer for the State Department of Agriculture.

On motion of Mr. Watkins, it was voted that Mr. Kelty be given leave of absence from June 15th, 1927 to September 20, 1927, four days each week, with pay.
