Beaumont Present, President Kedzie, Messrs. Woodman, Doherty, Graham/and Wallace. The minutes of the previous meeting having been in the hands of the members, were approved without reading.

On motion of Mr. Beaumont, Prof. Anderson was authorized to employ Mr. H. E. Dennison as special instructor in dairying from December 18, 1917, to March 1, 1918, at a salary of one hundred sixty-five dollars per month.

On motion of Mr. Woodman, Dr. Hibbard was authorized to attend a meeting of the Botanical Society of America, at Pittsburg, during the holidays, with allowance for his transportation expenses.

The Secretary presented the requests of Robert Shepard of Mio, Michigan, and Frank Dolton of Bath, Michigan, for the purchase of small amounts of timber upon College lands. On motion of Mr. Graham, this matter and other similar requests were referred to the Secretary with power to act.

On motion of Mr. Beaumont, the following committee of alumni, appointed by Mr. W. K. Prudden, president of the Alumni Association, to act in an advisory capacity with the Committee on Buildings and College Property, in connection with the rebuilding of College Hall, was approved:

Committee Chairman, Henry Haigh; Second member, Prof. A. C. Anderson; third member, Highway Commissioner Frank Rogers; fourth member, Association Secretary C. W. McKibbin; Ex Officio member, W. K. Prudden.

On motion of Mr. Woodman, the following report in relation to extension work, recommended by the Experiment Station Council for adoption by the Board of Agriculture, was approved:

*All extension work shall be under the control of an Extension Council. The Extension Council to have the following membership: President of College Director of Extension Dean of Agriculture Dean of Home Economics Dennison temporarily employed.

The first five officers named in the Extension Council shall compose the Executive Extension Committee.

All items of expenditure in the Extension budget shall have the approval of the Extension Council.

In the appointment of Extension Specialists, the following method shall be followed:

The head of the department in which the work is to be done shall select the candidate subject to the approval of the Dean of his division and the Extension Director. The latter shall transmit request for appointment to the President.

Extension Specialists shall be responsible to the head of the department for the subject matter taught, and to the Extension Director through the head of the department, for the administration of work in the field. In the establishment or revision of projects, the following method shall be followed: The head of the department concerned shall prepare project plan, or revise old project according to form established by the Federal Office. The project shall then be submitted to the Extension Director, who shall secure the approval of the Dean of the Division concerned before bringing it before the Extension Council.

All extension workers whose activities extend into the fields of two or more departments, as, for example, Boys and Girls Club work and the Director of Markets, shall, in so far as the nature of the project indicates, be responsible to the head of each department concerned.

Mr. Beaumont and Mr. Woodman desire to be recorded as voting "No" on the above motion.

The President presented the resignation of Research Assistant Charles W. Brown, to take effect January 1, 1918. On motion of Mr. Graham, the resignation of Mr. Brown, whose long and faithful service to the institution is deeply appreciated, was accepted, with regrets.

The President presented a communication from Mr. R. S. Hudson, Farm Superintendent, in relation to the sale of Percheron horses and the purchase of additional stock, which, on motion of Mr. Woodman, was referred to the President and Secretary for report at the next meeting.

On motion of Mr. Beaumont, the following recommendations of the faculty were adopted:

"Whereas, the United States Government, which has for over fifty years materially assisted in the support of this institution, has been forced into a state of war with a dangerous foe, and

Whereas, it is the natural consequence that this institution should and does consider its first duty that of wholehearted support of our federal government in its great undertaking, and

Whereas, there is a spirit of patriotic unrest pervading the younger members of the teaching force, arising from a feeling on their part that they are not sufficiently identified with the great governmental enterprises, and

Whereas, it is the firm conviction of this faculty that all the resources of the institution should be coordinated and made of greater service to war work. the government in this emergency,

Therefore, We request that the State Board of Agriculture empower the President to appoint a committee of the faculty to work with him and the heads of the respective divisions, in developing the following lines of cooperative emergency work for the college, viz.:

1st, Organization of educational extension service for high schools, etc.

2nd, Organization of teaching and research force for farmers' institutes and 2-day schools.

3rd, Organization of teaching and research force for coordination of college and county agent work.

4th, Organization of teaching and research force for service to extension specialists.

5th, Organization of exchange, intra and inter-departmentally, of members of teaching force.

6th, Organization of faculty for technical advice upon agricultural and industrial problems.
