We desire the appointment of E. O. Anderson as County Agent for Macomb at \$2400 per annum; this amount to be paid \$1200 by the College, and \$1200 by Macomb County, beginning September 23rd. Mr. Anderson is at present, County Agent in Maryland. He has held a position in the Department of Farm Management in Penna. State College. He was graduated here and later took post graduate work in Wisconsin.

I wish to report the conditions in Mason County which have report on conbeen irregular since July 1st. Funds were insufficient to warrant financial ditions in cooperation from us on the basis of a full year's work. For this reason the Mason Co. County was not included in the list submitted to the Board. Local interest, however, has been strong, and Mr. Cook has been influenced locally to stay Farm Bureau without any financial cooperation from us. During this time, the Farm Bureau organized. has been organized with the support of most of the better farmers backing it. It is their desire now to go to their Board of Supervisors for an appropriation and to reestablish their financial cooperation with the College. Inasmuch as this is one of the early counties to support the work, I would like to be authorized to offer the usual cooperation to the county, provided the county appropriation is secured.

The work Mr. Cook has done during July and August has resulted in a well organized Farm Bureau. I believe we should recognize this and pay Mr Cook \$100 per month for the two months, this being the uniform rate to all agents. The local people would feel better and Mr. Cook also \$100 per month if this is done. for Jul.& Aug.

Whereas the Pennsylvania Salt Manufacturing Company is considering the giving of a small building to the division of entomology of the Experiment Station, in order that the experiments on the control of gapes in poultry which are now under way, may be continued through the winter. I It is suggested that the Board may wish to consider the advisability of accepting provisionally the gift at a September meeting.

It is planned that if the structure is given and accepted will, be put up by the College on the campus in some suitable location designated by the College authorities. The Building to cost in the neighborhood of \$3000. It should be of concrete blocks or of brick and so built that it will be of pleasing appearance. The size to be 20 X 30 feet.

The action is desired at this time so that if the plan is approved and the building is offered soon, the construction may be commenced immediately before the material under experimentation is allowed to die out.

Dear President Kedzie:-

The following is a report of the Committee appointed by the State Board of Agriculture to confer with Mr. Graham with regard to plans for the future development of the Graham Station:

On Friday, August 29th, Mr. I. R. Waterbury, C. P. Halligan and myself met in Grand Rapids with Mr. Graham and visited the Station farm. The Committee submits the following recommendations, viz:

(1). It is highly desirable that funds and facilities be provided as promptly as possible in order to permit of the rapid establishment of the work to be undertaken especially the extensive and varied plantings essential to investigational and demonstration work. The Committee was impressed with Mr. Graham's views relating to the impending demand of the next few years for information relating to horticultural production.

(2). The Station should be superintended by a practical horticulturist, particularly through the planting and development stage. The superintendent should be an experienced man yet young enough so that the years of energy and ambition are before rather than behind him.

(3). While the work of the practical horticulturist must precede, to establish a basis, assignments of suitable scientific specialists may be made from the College during portions of the year as soon as the facilities, for their work is provided.

(4). The Committee desires Prof. Halligan to proceed with the preparation of plans to provide the most suitable possible landscape effect on the property frontage.

(5). The Committee feels that there is urgent need for ample funds and speedy provision of suitable buildings needed.

(6). Because of Mr. Graham's years of experience as a practical horticulturist, the Committee desires to look to him for continued guidance in the establishment and direction of the Station and will greatly appreciate the assistance he may continue to give.
