... TO RATIFY OR NOT TO RATIFY, THAT IS THE QUESTION...

As you probably know by now, the Equal Rights Amendment is on the calendar of the Hichigan House of Representatives for Tuesday, April 11, and will probably be voted upon. The Hichigan Senate will hold hearings on the eleventh beginning at 2:00 p.m. in the Seven Story Building, Lansing. It's important that women be present both in the House and at the Senate hearings; there is opposition to the passage of the ERA by women who fear certain protective labor laws will be lost. For those who have an interest in the legislative process, this should be an interesting day of hearings and discussions.

President Wharton's announcement of an "affirmative action" program to end discrimination against women within the University community is commendable as a too-long delayed response. There are, however, a few questions that came to mind as we read the SN article:

Is this a one-man affirmative action program or are others involved, aware, and concerned?

What women were consulted and involved in drawing up the plan? What women will be involved in its implementation?

What ever happened to those proposed salary adjustments? Why are they not to be retroactive? Other schools which have made similar adjustments have gone the retroactive route.

At the risk of sounding both skeptical and cynical, we also observed that there had been continued resistence to any "affirmative action" for women until the late February Board of Trustees' hearing...was the President's statement released in early March by coincidence or intent? Sometimes affirmative action and politics look a lot alike!
